SUMMARY OF DETAILS: Pocono Mountain Regional Police responded to a domestic incident with injuries at 319 Sidney Ave., Stillwater Lakes Civic Association, Pocono Summit, Coolbaugh Twp. Upon arrival, Ms. Benfatti was bleeding from a head wound and was not able to provide a statement. She was transported to Lehigh Valley- Pocono by Pocono Mountain Regional EMS and it was later learned that she suffered a severe head wound. The incident is under investigation. No charges have been filed at this time.

SUMMARY OF DETAILS: On the above date and time officers from the Pocono Mountain Regional Police Department responded to the Stillwater Lakes Clubhouse at 382 Stillwater Drive to assist EMS for a possible drowning. The incident occurred in the lake. Officers arrived within 4 minutes. At this time, numerous individuals were searching the water, but due to poor visibility, were having difficulty locating the juvenile. 7 PMRPD Officers arrived and began a search operation. During this time, one of the initial searchers successfully located the juvenile male in about 10' of water. Ambulance and Police began CPR and promptly transported the juvenile to a waiting ambulance. The juvenile was then rushed to Lehigh Valley Hospital-Pocono in critical condition with police escort. The juvenile was then transported via MedEvac to Lehigh Valley Hospital-Cedar Crest for further care. On 7/2/2018, Police were notified via Lehigh County Coroners Office that the juvenile has passed. At the present time, police believe the incident to be accidental.
