SUMMARY OF DETAILS: Pocono Mountain Regional Police are investigating a fatal motor vehicle crash, which occurred on Sunday October 22nd, 2017 at 7pm. The crash occurred at the intersection of State Route 423 and I380 South on-ramp. Edward Hoffman, 58 of Weatherly, was traveling North on SR 423 operating a Harley-Davidson motorcycle, when he was involved in a motor vehicle crash with Ian Watkins, 50 of Allentown. Mr. Watkins was traveling South on SR 423 in a Nissan Pathfinder, Watkins was attempting to enter the I380 South on-ramp at the time of the crash. Mr. Hoffman died as a result of injuries sustained in the motor vehicle crash.

SUMMARY OF DETAILS: The Pocono Mountain Regional Police are reconstructing a motor vehicle crash that occurred on State Route 196 involving a pedestrian. The pedestrian, a 17 year old male, had just exited a Pocono Pony bus at SR 196 and Woodside Drive just prior to the crash. After exiting the bus, the juvenile crossed SR 196 and was struck by a Hyundai Elantra which was traveling south. The Hyundai was operated by Joaquin Acevedo Soltren. The juvenile was flown to Geisinger Community Medical Center, but succumbed to his injuries. SR 196 was closed for approximately 5 hours while police conducted the on-scene investigation and forensically mapped the area. Police were assisted by the Coolbaugh Twp. VFD and Pocono Mountain Regional EMS. The investigation is continuing and anyone that may have information is asked to call Officer Daniel Jones.
