The Pocono Mountain Regional Police are announcing the arrest of Eric Jones, 31 years old, from Tobyhanna Pennsylvania for the Criminal Homicide of Morgan McGee, 28, also of Tobyhanna.


On 7/11/2017, at approximately 0320 hours, the Pocono Mountain Regional Police were dispatched to 6107 Boardwalk Drive in Tobyhanna Pennsylvania for a deceased female. Upon arrival, police found one Morgan McGee deceased within the residence.

McGee had signs of trauma and what appeared to be a gunshot wound to the face. The police investigation revealed that the original caller was a relative of Morgan McGee's boyfriend. The boyfriend and the father of McGee's child is one Eric Jones. The relative had been contacted by on Steven Lundy and told to go to 6107 Boardwalk Drive to retrieve the child. Upon the relatives arrival, McGee was discovered at which point police were notified.

The police investigation determined that earlier in the morning, arguing was heard coming from the home, followed by two possible gunshots. A vehicle was then seen fleeing the home. A witness related that the vehicle that left the residence was known to be that of McGee and Jones and that the driver of the vehicle appeared to be Jones. The investigation further uncovered that the only occupants of the home are McGee, Jones and their child.

While Police were on-scene, Eric Jones arrived on foot. Jones was determined to be intoxicated and created a disturbance. Jones was subsequently taken into custody for Public Drunkenness. The continuing police investigation revealed that Jones showed up at Steven Lundy's home and was highly intoxicated. Lundy and Jones are friends. During this time, Jones related that he had been in an altercation with McGee. Jones was also concerned about the child being at home prompting Lundy to seek out assistance with the child. Lundy eventually dropped Jones off at Jones' parents home.

Police were then provided with a description of what Jones was wearing during this time, which was not entirely consistent with what he was wearing when taken into custody. Police learned that prior to being taken into custody, Jones had been wearing different footwear. Police then located this footwear at Jones' parent home. The footwear was found to have blood stains. During the search warrant of the Boardwalk Drive home, the victim was found to have sustained two wounds consistent with gunshots. Police also located evidence consistent with drug dealing and transactions including cellular communications. Jones was taken to the Monroe County Correctional Facility and will be arraigned on 7/12/2017.
