**SUMMARY OF DETAILS:** On this date officers observed the above individuals acting suspiciously in the area of SR 390 and Golf Drive. Officers then made contact with them at 124 Golf Drive. Several of the people did not live there and shortly after our arrival a male exited the residence and ran through the woods away from the scene. Investigation revealed that the male, later identified as Edward Kulick, was wanted on a County Bench Warrant. As this was unfolding Wheaton, Morton and Dean consented to a pat down search for weapons and Morton was found in possession of drug paraphernalia. A search of the area for Kulick, utilizing a Police K-9 and additional officers located him nearby and he was taken into custody. An interior search of 124 Golf Drive revealed another man, Brian Brown, was located hiding in the attic and was also wanted on a County Bench warrant. A further investigation at the property placed Misty Dean and Kristle Wheaton in possession of drug paraphernalia and they will be charged via summons.
