SUMMARY OF DETAILS: On the above date and time, Police were conducting traffic enforcement. The vehicle being driven by MELENDEZ-GONZALEZ was stopped for speeding (76 mph in an allowed 55 mph zone.) While speaking with both individuals a strong odor of marijuana was emanating from the vehicle. Both acknowledged that they smoked marijuana and that marijuana was present inside the vehicle. Consent to search was obtained and a large quantity of marijuana was found along with a scale and packaging material. An unregistered 9mm handgun was also found with the marijuana. Both were arrested and taken to the processing center. MELENDEZ-GONZALEZ will be charged with Possession with intent to deliver, Possession of marijuana, Possession of Drug Paraphernalia, Criminal Conspiracy, Carrying a Firearm without a License, DUI and traffic violations. WILSON will be charged with Possession with intent to deliver, Possession of marijuana, Possession of Drug Paraphernalia, Criminal Conspiracy, Carrying a Firearm without a License.

**SUMMARY OF DETAILS:** On the above date and time, Police responded to a reported domestic disturbance with a knife. It was reported that someone was stabbing at the residence. Upon arrival police observed that BOKOW was stabbed twice in the head. BOKOW was bleeding heavily at the time. KLEBETZ was struck in the left eye and cheek area. This area appeared to contain broken bones. KLEBETZ was transported to the hospital. BOKOW refused to be taken to the hospital after being treated by EMS. Subsequently during interviews KLEBETZ stated that BOKOW punched her in the head and she stabbed him. BOKOW stated that he was trying to subdue KLEBETZ and take the knife away and might have punched her. Both were arrested after treatment. Both were arraigned before Magisterial Judge TRAVAGLINE with bail set at unsecured.
