CALL TO ORDER:

The Regular Business Meeting of the Pocono Mountain Regional Police Commission was held at the Pocono Mountain Regional Police Building and called to order at 7:00 p.m. by Chairman Moyer with the Pledge of Allegiance.

ROLL CALL:

EXECUTIVE SESSION

There was an Executive Session prior to the Regular Meeting on litigation. The Executive Session started approximately 6:30 p.m. and ended approximately 6:55 p.m.

APPROVE MINUTES:

Motion:

Francis DePiano made a motion to adopt the minutes of 10 January 2023 Reorganization/Regular Business Meeting, seconded by William Weimer. The motion passed unanimously.

APPROVE BILLS:

Motion:

Francis DePiano made a motion to approve the Bill-pack of 14 February 2023 in the amount of \$242,731.20, seconded by Brendon Carroll. The motion passed unanimously.

POLICE REPORT:

Total calls for the month of January were 1073 consisting of 969 Complaints and 104 Accidents. There were a total of 105 Criminal Arrests, 109 Traffic Arrests, 129 Traffic Warnings and 12 Ordinance Arrests.

Chief Wagner advised that the Speed Timing/Vascar statistics would be categorized differently on the monthly report going forward. The Chief reviewed the monthly and year to date activity numbers per municipality as well as the UCR Crime Stats.

Motion:

Francis DePiano made a motion to accept the January Police Report, seconded by William Weimer.

Kurt Cummings asked Chief Wagner if the fraud category of crimes was due to retail theft. Chief Wagner responded that retail theft charges do not fall under this heading and that it is mostly identity theft and credit card fraud.

With no additional comments or questions, the motion passed unanimously.

VEHICLE REPORT:

Chief Wagner reviewed the mileage and expense report for January.

Motion:

Francis DePiano made a motion to accept the January Vehicle Report, seconded by William Weimer. The motion passed unanimously.

NEW BUSINESS:

• Hiring Bonuses

The challenge and difficulty in law enforcement to recruit new officers is significant and continues to grow. The industry is continuously looking for new and creative ways to attract qualified candidates. Chief Wagner explained that while the application for American Recovery Act funds included a request for hiring and retention bonuses, the award has still not been offered as of today's date. Chief Wagner asked the board for discussion and approval of the Commission's support in funding the \$10,000 hiring bonuses from the budget in the event that they are not approved through the ARA Grant. The department is currently down six officers.

The Chief's primary concern is to get the hiring process started to avoid any further delays which could result in delaying Academy enrollment for up to one year.

Fran DePiano asked if retention bonuses would also be part of the plan. Chief Wagner replied in the affirmative. Retention bonuses were written into the grant request as well but are a separate line item from hiring bonuses.

Motion:

Francis DePiano made a motion to approve a \$10,000 hiring bonuses for new officers and the advertising for same, seconded by William Weimer. The motion passed unanimously.
