#### ITEM #1.

NOMINATION FOR CHAIRMAN
MARIO SCAVELLO MADE A MOTION TO NOMINATE ALFRED A.
KERRICK TO SERVE AS CHAIRMAN OF THE POCONO MOUNTAIN
REGIONAL POLICE COMMISSION, SECONDED BY DAVID MOYER.
ALL MEMBERS OF THE POCONO MOUNTAIN REGIONAL POLICE
COMMISSION VOTED IN FAVOR.

## ITEM #2. NOMINATION FOR VICE-CHAIRMAN ALFRED A. KERRICK MADE A MOTION TO NOMINATE ROY GROSS TO SERVE AS VICE-CHAIRMAN OF THE POCONO MOUNTAIN REGIONAL POLICE COMMISSION, SECONDED BY DAVID MOYER. ALL MEMBERS OF THE POCONO MOUNTAIN REGIONAL POLICE COMMISSION VOTED IN FAVOR.

# ITEM #3. CHIEF OF POLICE SELECTION UPDATE SPEAKER RON SMEAL AFTER OUR LAST MEETING WE RECEIVED FOUR ADDITIONAL APPLICATIONS TO BRING THE TOTAL TO TWENTY NINE. THE SUCCESSFUL AND THE UNSUCCESSFUL APPLICANTS WERE NOTIFIED OF THE ONES THAT WERE SELECTED FOR AN INTERVIEW FOR NEXT WEEK. WE HAVE HAD ONE WITHDRAW,

MR. SMITH FROM THE PITTSBURG POLICE DEPARTMENT HAS WITHDRAWN. THE PANEL HAS BEEN CONTACTED AND ARRANGED EVERYTHING TO PREPARE, SO WE ARE READY FOR THE 22ND.

ALFRED KERRICK ANNOUNCED THAT HE WOULD LIKE TO GO OVER THE APPLICATIONS, AND WILL RUN AN EXECUTIVE SESSION AT A LATER DATE.

RON SMEAL STATED THAT THE FIRST INTERVIEW IS SET FOR EIGHT O'CLOCK ON THE 22ND OF JANUARY 1994.

ALFRED KERRICK STATED THAT BOTH CHIEF'S FROM MT. POCONO AND FROM TOBYHANNA TOWNSHIP ARE ON THE LIST OF APPLICANTS.

RON SMEAL STATED THEIR ARE SIX ADDITIONAL APPLICANTS. THE CHIEFS FROM MT. POCONO AND FROM TOBYHANNA TOWNSHIP ARE THE FIRST TWO ON THE LIST.

#### ITEM #4. NOMINATION FOR SECRETARY

ALFRED KERRICK ADDED AN ADDITIONAL ITEM THAT WAS NOT LISTED ON THE AGENDA, WHICH IS TO ELECT A SECRETARY FOR POCONO MOUNTAIN REGIONAL POLICE COMMISSION MEETINGS. THIS WAY THE MINUTES CAN BE DONE.

KELLY L. BIDDLE VOLUNTEERED AS SECRETARY FOR THE POCONO MOUNTAIN REGIONAL POLICE COMMISSION MEETINGS.

ROY GROSS MADE A MOTION TO NOMINATE KELLY L. BIDDLE TO SERVE AS SECRETARY FOR THE POCONO MOUNTAIN REGIONAL POLICE COMMISSION, SECONDED BY MARIO SCAVELLO. ALL MEMBERS OF THE POCONO MOUNTAIN REGIONAL POLICE COMMISSION VOTED IN FAVOR.

#### ITEM #5. DISCUSSION OF COMMITTEE ASSIGNMENTS:

- A. INVENTORY
- B. PATCH

ALFRED KERRICK DISCUSSED THAT THE TWO COMMITTEE ASSIGNMENTS CAN BE ADDED TO. THE INVENTORY AND THE PATCH WERE THOUGHT OF BY KELLY BIDDLE AND RON SMEAL FOR AGENDA. ALFRED KERRICK STATED AS A STUDY TEAM, THIS IS SOMETHING WE WOULD LIKE TO GIVE TO THE POLICE DEPARTMENTS TO WORK ON THEM, AND GET INVOLVED WITH. ALFRED KERRICK OPENED THE DISCUSSION TO RON SMEAL BECAUSE HE HAS PRIOR EXPERIENCE THROUGH OTHER POLICE DEPARTMENTS.

RON SMEAL DISCUSSED THAT MANY POLICE OFFICERS FROM OTHER DEPARTMENTS CAME UP WITH THEIR OWN IDEAS AND DESIGNS FOR THEIR PATCH AND UNIFORMS, AND ALSO HAVING SCHOOL DISTRICT REPRESENTATIVES AND MUNICIPALITIES TO HELP WITH THEIR RECOMMENDATIONS FOR THE UNIFORM. THE INVENTORY SHOULD BE DONE FOR CALCULATIONS FOR BUDGET.

FROM EACH DEPARTMENT, ALL THE EQUIPMENT, PATROL CARS, WEAPONS, AND ANY OTHER EQUIPMENT THAT WOULD BE INVOLVED WITH POLICE DEPARTMENT WORK.

RON SMEAL STATED IT WOULD THEN BE DISCUSSED WITH THE STUDY TEAM AND THE POLICE OFFICERS.

FROM THE MT POCONO POLICE DEPARTMENT.
MORITZ WAS MENTIONED IN REGARDS TO A DESIGN.

ALFRED KERRICK QUESTIONED JOHN LAMBERTON FROM THE TOBYHANNA TOWNSHIP POLICE DEPARTMENT IN REGARDS TO THE INVENTORY AND THE PATCH?

JOHN LAMBERTON STATED THAT NO INVENTORY WAS TAKEN AS OF YET. THE DEPARTMENT IS WORKING ON SEVERAL DESIGNS ON A PATCH. OFFICER MARTY REYNOLDS FIANCEE WORKS AS A GRAPHIC ARTIST AT MORITZ IN MT POCONO AND IS HELPING IN DESIGNING THE PATCH FOR US.

ALFRED KERRICK WOULD LIKE THE TWO DEPARTMENT'S TO DECIDE ON THE PATCH.

RON SMEAL QUESTIONED THE PATCH?

ALFRED KERRICK STATED THAT THE PATCHES ARE PRESENTLY ROUND, BUT DO NOT NECESSARILY HAVE TO REMAIN THAT WAY.

RON SMEAL MADE SOME SUGGESTIONS REGARDING THE PATCH.

JOHN LAMBERTON DISCUSSED THE PATCH.

ALFRED KERRICK WOULD LIKE THE POLICE OFFICERS TO DECIDE ON THE PATCH, AND IF THERE SHOULD BE ANY CHANGES TO DECIDE ON THEM AND BRING THEM BACK FOR DISCUSSION.

BE MADE TO BRING THEM BACK FOR DISCUSSION.

..... BROUGHT UP THE PATROL ZONES, AND THEIR LAYOUT IN MT. POCONO BOROUGH.

ALFRED KERRICK QUESTIONED TOM .....IN REGARDS TO WHAT THE MT POCONO COUNCIL WANTS?

TOM.....SAID AS FAR AS DAYS OF THE WEEK, NOTHING HAS BEEN SET.

ALFRED KERRICK TOLD THE DEPARTMENT'S THAT IF THERE IS ANYTHING ELSE THAT THEY WOULD LIKE TO GET INVOLVED WITH, TO LET HIM KNOW.

JEFF EVANS ASKED IF THE CARS WOULD BE REDONE RIGHT AWAY OR WHEN THEY NEED TO BE REPLACED?

ALFRED KERRICK MENTIONED THAT THE CARS LOGO AND STRIPING WOULD BE CHANGED, AND ALSO MENTIONED THAT MT. POCONO CARS ARE A DIFFERENT COLOR.

ALFRED KERRICK FEELS IT IS IMPORTANT THAT THE DEPARTMENT GETS BACK TO US WITH THEIR RECOMMENDATIONS AND THEN WE CAN LOOK AT THIS FINANCIALLY. WE WILL KNOW IF WE CAN AFFORD TO DO THIS ALL AT ONCE OR PHASE IT IN.

RON SMEAL SAID ONCE WE SIT DOWN AFTER THE CHIEF SELECTION IS OUT OF THE WAY, INVENTORY, EVIDENCE, NOTIFYING THE DISTRICT ATTORNEY, GETTING THE TELEPHONES STRAIGHTENED OUT, AND ALL THE OPERATIONAL THINGS YOU CAN SEE WHERE YOU ARE. SOME THINGS CAN WAIT AND BE PHASED IN LATER. THE COMPUTER SYSTEM, TIME SHEETS, AND ALL THE ADMINISTRATIVE THINGS ALSO HAVE TO BE DONE.

ITEM #6 PENSION PLAN
SPEAKER TOM KLAUM - PENNSYLANIA STATE ASSOC.
OF BOROUGHS.

BERNARD PALLO MENTIONED THAT THOMAS KLAUM IS THE ASSISTANT EXECUTIVE VICE-PRESIDENT FOR THE STATE ASSOCIATION OF BOROUGHS. MT. POCONO HAS A PENSION PLAN WITH THE PENNSYLVANIA STATE ASSOCIATION OF BOROUGHS.

TOM KLAUM THANKED EVERYONE FOR THE OPPORTUNITY TO PRESENT THE RETIREMENT TRUST TO THE GROUP. IT COVERS SEVERAL ITEMS.

THE STATE ASSOCIATION OF BOROUGHS HAS HAD A TRUST SINCE 1972, AND CURRENTLY HAVE APPROX. 140 MUNICIPAL PLANS IN THE TRUST: A VARIETY OF UNIFORM AND NON-UNIFORM PLANS AND ALSO BOROUGH AND TOWNSHIP PLANS. THERE IS APPROX. 42 MILLION DOLLARS IN THE TRUST THAT WE ADMINISTER. THE ASSOCIATION OF CLERKS CONTRACTS OUT THE PROFESSIONAL EXPERTISE TO RUN THE TRUST.

THERE IS A BOARD OF DIRECTORS, A BOARD OF TRUSTEES MADE UP OF ELECTED OFFICIALS FROM GOVERNING BODIES THROUGHOUT THE STATE THAT OVERSEE THE TRUST ITSELF. THERE IS TWO PROFESSIONAL FIRMS THAT ARE HIRED. ONE THAT IS A GENERAL ADMINISTRATOR FOR THE TRUST AND THE OTHER IS OUR INVESTMENT ADVISOR.

TOM KLAUM WENT OVER THE PENSION PLAN INFORMATION BOOKLET. ACT 205 WAS IN EFFECT AROUND 1984 WHICH STRAIGHTENED OUT THE SAFE GUARD MUNICIPAL PENSIONS, BY PUTTING SOME RESTRICTIONS ON.

TOM KLAUM SPOKE OF OTHER PROFESSIONAL GROUPS: BANK TRUST DEPARTMENTS INSURANCE COMPANIES, INDEPENDANT MUNICIPAL PENSION CONSULTANTS, ACTUARIES, INVESTMENT ADVISOR FIRMS.

TOM KLAUM MENTIONED ONE OF THE MAJOR MUNICIPAL PENSION GROUPS IN PENNSYLVANIA THAT WAS CREATED BY STATUE IS P.M.R.S. - PENNSYLVANIA MUNICIPAL RETIREMENT SYSTEM. TOM KLAUM SAID THAT HIS SYSTEM AND P.M.R.S. PROVIDE A PACKAGE SITUATION WHERE ALL THE NEEDS THAT YOU HAVE FOR YOUR PENSION PLAN ARE MET.

TOM KLAUM DISCUSSES THE FIVE CATEGORIES OUTLINED.

- 1. CREATING DOCUMENTS
- PLAN DOCUMENT
- 3. JOINDER AGREEMENT
- 4. ADMINISTRATION OF PLAN
- 5. INVESTMENT ASSETS

TOM KLAUM DISCUSSES THE P.S.A.V. TRUSTEES AND STAFF.

TOM KLAUM SPOKE OF THE INVESTMENT ADVISOR WHO ADVISES THE MERRILL LYNCH FIRM. WHAT STOCKS TO BUY AND SELL. HE KEEPS THE FEE DOWN TO 8 CENTS PER SHARE. IF HE CAN NOT MOVE IT, OR SELL IT, OR BUY IT, THEN THEY LOOK FOR ANOTHER BROKER.

TOM KLAUM DISCUSSED THE VALUE OF ASSETS, WHICH ADDRESSES THE CONTRIBUTIONS THAT GO IN, EXPENSES THAT ARE PAID OUT AND TOTAL RETURNS.

TOM KLAUM THEN SHOWED EXAMPLES OF HOW THIS WORKS.

TOM KLAUM DISCUSSED HOW THE STOCK AND BONDS WORK.

TOM KLAUM DISCUSSED THE EXIT COSTS. IF YOU SHOULD TERMINATE, IT TAKES 60 DAYS FROM THE TIME YOU WANT TO TERMINATE, THEN THE MONEY WOULD BE SENT TO YOU.

....... HAD A QUESTION IN REGARDS TO BENEFIT TOBYHANNA TOWNSHIP, MT. POCONO IS A BOROUGH AND BELONGS TO THE PENNSYLVANIA STATE POLICE ASSOCIATION OF BOROUGHS. SINCE TOBYHANNA IS A TOWNSHIP, IS THERE A FEE FOR THE TOWNSHIP TO COME INTO THE ASSOCIATION?

TOM KLAUM DISCUSSED DUES STRUCTURE FOR MEMBERS. MUNICIPAL ASSOCIATE MEMBERSHIP, WHICH IS THE MEMBERS WHO PAY DUES. THE FEE IS \$125.00 PER YEAR. THE REGIONAL GROUP COULD BE A MEMBER FOR \$125.00 PER YEAR.

WOULD BE TREATED THE SAME AS THE TOWNSHIP BECAUSE THEY ARE NOT A BOROUGH.

TOM KLAUM DISCUSSED THAT THEY HAVE A COMPENSATION UNEMPLOYMENT PROGRAM.

ITEM #7 ADVERTISEMENT FOR SOLICITOR FOR POCONO MOUNTAIN REGIONAL POLICE COMMISSION.

..... MADE A MOTION TO ADVERTISE FOR A SOLICITOR FOR THE POCONO MOUNTAIN REGIONAL POLICE COMMISSION, SECONDED BY.........

ALFRED KERRICK MADE A MOTION TO RUN THE ADD FOR SOLICITOR FOR THE POCONO MOUNTAIN REGIONAL POLICE COMMISSION IN THE POCONO RECORD NEWSPAPER ON FRIDAY, 16 JANUARY 1994. ALL MEMBERS IN FAVOR.

ALFRED KERRICK SAID ALL APPLICATIONS MUST BE IN NO LATER THAN THE 25TH OF JANUARY 1994.

ITEM #8 ADVERTISEMENT FOR POSITIONS OF PATROLMAN FOR THE POCONO MOUNTAIN REGIONAL POLICE DEPT.

.....QUESTIONED HOW MANY PATROLMAN DO WE INTEND TO HIRE?

ALFRED KERRICK SAID WE NEED TO ADD FOUR ADDITIONAL PERSONNEL.

..... SUGGESTED THAT WE CAN JUST ADVERTISE FOR APPLICANTS FOR THE POSITION, AND THEN HIRE AS MANY AS YOU NEED.

KELLY BIDDLE QUESTIONED IF WE SHOULD DO THIS PRIOR TO THE HIRING OF THE CHIEF?

RON SMEAL STATED UNTIL WE START TO DO ALL OF THIS, IT WILL JUST FALL IN LINE.

ALFRED KERRICK SAID TO PUT THE AD IN NOW, SO WHEN THE CHIEF IS HIRED THE APPLICATIONS ARE ALREADY BEING SUBMITTED BACK TO US.

ALFRED KERRICK MENTIONED CHANGING THE NAME FROM TOBYHANNA TOWNSHIP TO POCONO MOUNTAIN REGIONAL POLICE DEPARTMENT.

..... MENTIONED THAT THE MOUNT POCONO POLICE DEPARTMENT HAS RECEIVED APPLICATIONS FOR PART TIME POLICE OFFICERS, SO THESE APPLICATIONS WOULD NOT EVEN BE CONSIDERED, BECAUSE THEY ARE A YEAR OLD.

ALFRED KERRICK MENTIONED USING THE SAME WORDING IN THE ADVERTISEMENT AS THE LAST TIME.

APPLICANTS FOR POLICE OFFICER, SECONDED BY......

KELLY BIDDLE QUESTIONED WHEN THE RESUME'S SHOULD BE IN BY?

ALFRED KERRICK MENTIONED THIRTY DAYS.

..... SAID BY THE 14TH.

KELLY BIDDLE QUESTIONED ABOUT ONLY RUNNING THE AD FOR ONE DAY? IN WHAT NEWSPAPER'S?

ALFRED KERRICK ASKED HOW WE RAN OUR LAST AD FOR POLICE OFFICER?

KELLY BIDDLE SAID THE AD'S WERE RUN ON A WEDS., SAT. AND THEY WERE IN THREE DIFFERENT NEWSPAPERS.
THE TIME'S LEADER, POCONO RECORD AND THE MORNING CALL.

..... SAID THAT SOUNDS LIKE A GOOD IDEA.

ALL MEMBERS AGREED, THAT IS WHAT WOULD BE DONE TO THE OLD APPLICATION'S.

DAVE MOYER ASKED HOW MANY APPLICATIONS WE RECEIVED FOR TOBYHANNA TOWNSHIP?

ALFRED KERRICK MENTIONED THERE WERE SEVENTY SOME APPLICATIONS RECEIVED, I BELIEVE.

JOHN LAMBERTON BELIEVES THERE WERE SEVENTY THREE.

..... SAID THEY RECEIVED THIRTY SOMETHING APPLICATIONS JUST FOR PART TIME MOUNT POCONO POLICE OFFICERS, AND WE ADVERTISED SEVERAL DIFFERENT TIMES.

GOOD, THEN THEY WOULD HAVE TO REAPPLY.

THE MEMBERS AGREED THAT THEY WOULD HAVE TO REAPPLY.

ALFRED KERRICK SAID BECAUSE THEY WERE APPLYING FOR TOBYHANNA TOWNSHIP POLICE DEPARTMENT, RATHER THEN THE POCONO MOUNTAIN REGIONAL POLICE DEPARTMENT.

ALFRED KERRICK SAID HE RECEIVED A LETER DATED
10 JANUARY 1994 FROM A JOHN PATTON IN REGARDS
TO THE GRANT APPLICATION BEING INCOMPLETE AS
PRESENTED. THE RESOLUTION FROM MOUNT POCONO
IS MISSING. THEY ARE BOTH THERE, ONE IS SIGNED.

ALFRED KERRICK MENTIONED THERE ARE FOUR THINGS, BUT ACCORDING TO KELLY THE FOURTH THING IS JUST ADMINISTRATIVE.

ALFRED KERRICK MENTIONED THAT THE FOURTH WAS FEASIBILITY STUDY INDICATION, THE COST WILL BE SPLIT SEVENTY-THIRTY. THE GRANT REQUEST SHOWS AN EIGHTY-TWENTY.

RON SMEAL SAID THAT ALL YOU NEED TO DO IS AFTER AFTER FURTHER STUDYING THE REVIEW, WE FELT THAT THIS WAS A MORE WORKABLE ARRANGEMENT.

ALFRED KERRICK MENTIONED BECAUSE IT IS A FEASIBILITY STUDY, IT SHOULD BE DONE BY YOU.

#### DISCUSSION OPEN TO PUBLIC

MR. BURT WISHES THE COMMISSION AND THE NEW FORCE WELL. GOOD LUCK.

JEFF EVANS HAD A QUESTION REGARDING AFTER THE CHIEF IS DETERMINED, HOW WOULD THE REST OF THE LINE OFFICERS BE DETERMINED?

ALFRED KERRICK MENTIONED THE DISCUSSION WITH THE STUDY TEAM IS THAT THE CHIEF IS GOING TO BROUGHT INTO THAT, HOWEVER THERE HAS NOT BEEN ANY FIRM DECISION IN REGARDS TO THAT. THE INDIVIDUAL THAT IS GOING TO BE THE HEAD OF THE DEPARTMENT SHOULD HAVE A SAY AS TO HOW THE LINE OFFICERS ARE CHOSEN.

JOHN LAMBERTON SPOKE ON BEHALF OF THE TOBYHANNA TOWNSHIP POLICE DEPARTMENT. HE SUGGESTED THAT THERE SHOULD BE A PENSION BOARD FORMED AS A SEPERATE ENTITY FROM THE POLICE COMMISSION BOARD. BECAUSE WE WILL BE STARTING OUT WITH FIFTEEN EMPLOYEES AND GROW LARGER FROM THERE.

ALFRED KERRICK MENTIONED THAT THIS SUGGESTION CAME UP AT THE LAST STUDY TEAM MEETING, AND FEELS THAT IT IS A GREAT SUGGESTION, AND THAT THE COMMISSION IS NOT OPPOSED AT ALL.

JOHN LAMBERTON SUGGESTED THAT IT COULD BE SOMETHING THAT RON SMEAL CAN ADVISE THE DEPARTMENT OF.

RON SMEAL SAID TO SET UP THE BOARD EXACTLY
THE WAY YOU DISCUSSED IT. HE MENTIONED THAT
A MEMBER FROM THE OFFICERS ASSOCIATION, AND
AT THE REORGANIZATIONAL MEETING, A COMMISSION
MEMBER IS APPOINTED TO THAT BOARD, AND THEN
A CITIZEN FROM THE COMMUNITY, A VERY KNOWLEDGABLE
PERSON IN PENSIONS, AND FINANCES. THAT BOARD WOULD
GOVERN THE PENSION AND DOES THE LEG WORK AND
MAKES RECOMMENDATIONS TO THE BOARD.

.........SAID THAT FOR EXAMPLE IT WOULD WORK SOMETHING LIKE A PLANNING COMMISSION WOULD WORK FOR A BOROUGH. THERE WILL BE AN ADVISORY CAPACITY TO DO THE STUDY AND A MAKE SUGGESTIONS, AND RECOMMENDATIONS.

RON SMEAL SAID BECAUSE THERE WILL BE NO MUNICIPAL MANAGER, SO YOU WOULD THEN NEED A PLAN ADMINISTRATOR, THROUGH THE AUDITOR GENERAL ONE OF THE FINDINGS IN OUR PLANS WERE BECAUSE THERE WAS KNOW ONE ELSE. LIKE THE CHIEF OF POLICE, THERE WOULD BE A PLAN ADMINISTRATOR, WHO WOULD DO THE PAPER WORK, AND FORWARD IT BACK TO THE MUNICIPALITY. THIS WAY EVERYTHING IS AUDITED, AND ACCOUNTABLE. THE MONIES ARE FLOWED TO THE MUNICIPALITIES FROM THE STATE, WHICH ARE CASUALTY MONIES, AND THEN AN AUDIT TRAIL WOULD GO FROM THE POLICE DEPARTMENT TO THE BANK. THEN EVERYTHING IS ACCOUNTED FOR. THEN YOU NEED TO DRAW UP A NEW PLAN DOCUMENT FOR THE DEFINED BENEFITS DECIDING UNDER HOW YOU WANT TO BE GOVERNED, WHAT LAWS YOU WANT TO APPLY, WHO YOU ARE GOING TO HAVE YOUR PENSION WITH.

ALFRED KERRICK WOULD LIKE TO SET THE BOARD AT THE NEXT MEETING. ONE PERSON FROM COMMISSION, ONE OFFICER, AND ONE PERSON FROM THE PUBLIC.

RON SMEAL SAID THE OFFICERS ASSOCIATION COULD BE THINKING OF A MEMBER WHOM THEY WANT TO REPRESENT. THEN DECIDE WHO YOU WANT FROM THE AREA WHO IS KNOWLEDGABLE WITH PENSION PLANS AND FINANCES.

## ITEM #1. APPOINT MEMBERS TO POLICE PENSION BOARD ONE YEAR TERM

Alfred Kerrick made a motion to appoint Mario Scavello to serve as Representative of the Pocono Mountain Regional Police Commission to the Police Pension Board, seconded by Roy Gross. All members voted in favor.

Dave Moyer made a motion to appoint David Cook to serve as Representative of the Police Department to the Police Pension Board, seconded by Mario Scavello. All members voted in favor.

Kelly Biddle made a motion to appoint Robert Hackenberg to serve as Citizen Representative to the Police Pension Board, seconded by Dave Moyer. All members voted in favor.

Roy Gross made a motion to form a Police Pension Board, terms of one year, seconded by Kelly Biddle. All members voted in favor.

## ITEM #2. APPOINTMENT OF SOLICITOR POCONO MOUNTAIN REGIONAL POLICE COMMISSION

Alfred Kerrick discussed the two applicants for solicitor.

#### LETTER HEAD/ENVELOPES

Kelly Biddle mentioned the need for new letter head, but thought it would be best to wait on the new logo first before ordering. Generic letter head will be used until we have the new logo.

Roy Gross mentioned that it would be best to wait until samples are submitted for the new logo, before ordering letter head and envelopes, hopefully by the next meeting.

#### BANK ACCOUNTS

Roy Gross suggested we should look into a local bank so this way it would be easier when making deposits, cashing checks, etc.

Tom Reed recommended looking into the First National Bank of Palmerton, they have a free checking, with no service charge.

Roy Gross suggested researching into a bank that can give us the better service.

Kelly Biddle raised a question as to whom would be signing these checks, and suggested at least two people would be needed to sign them.

Roy Gross suggested having the President of the Commission and the secretary to sign the checks.

Kelly Biddle questioned whether or not a Treasurer would also be needed?

Ron Smeal recommended getting signature cards, this way any member can sign, as long as there is two signatures. By just designating only two might not work out.

Mario Scavello made a motion to set up a bank account with either PNC Bank, First National Bank of Palmerton or Mellon Bank and to set up signature cards for the five members on the board. Alfred Kerrick would be the main signature, second signature would be any of the four members, seconded by Roy Gross. All voted in favor.

Kelly Biddle suggested monies needed in order to set the bank account up.

Alfred Kerrick mentioned contributions requesting each Municipality to start account.

Kelly Biddle suggested looking into PLIGIT to invest all money there.

#### ITEM #4 COMPUTER PROGRAM

Kelly Biddle suggested setting up the Townships old 36 computer in the Regional Police Department. This system would be sold to the Regional Police Dept. Mentor System would need to be contacted in order to set the program up. This System would be for budgeting, accounting, and personnel payroll.

Ron Smeal suggested if this is for budgeting and personnel and it's going to be sold to the Regional Police Department, then the Township should take care of the cost.

Alfred Kerrick mentioned that the monies are available in the Regional budget to buy the system.

Ron Smeal suggested looking at the cost of changing system and find out how much the Township will charge the Commission for the payroll services. Then make your decision.

Kelly Biddle mentioned the computer system in the Tobyhanna Township Police Department is approx. five years old.

Bernard Pallo suggested getting a new system for the Regional Police.

Ron Smeal mentioned some money from grant can be used for the computer.

Roy Gross mentioned that Mt. Pocono's computer could not produce billing as quickly.

Ron Smeal mentioned that his Department is upgrading their computer system. The system is a 386 and can handle three times as much input as Tobyhanna Township Police Departments can. Would like the Commission to consider looking into it.

Kelly Biddle will be checking into the computer system further.

Ron Smeal mentioned that Street Guard is the software that the Tobyhanna Township Police Dept. is presently using. Street Guard is familiar with consolidation. They have a lot of programs available.

#### ITEM #5 APPLICATIONS FOR POLICE OFFICER

Kelly Biddle mentioned there is a tremendous response to the ad for applications for the position of police officer. The cost to send these applications out is ninety eight cents per application. Because of the cost to send the applications it might be better to test everyone.

Ron Smeal mentioned that DCA-Department of Community Affairs will do the test labor free, but charges \$12.50 per applicant.

Kelly Biddle mentioned the fee for the test in December of 1993 was \$10.00 per applicant.

Roy Gross mentioned that the Mt. Pocono Borough gave a civil service test.

Alfred Kerrick suggested the applicants who are writing for applications are to be notified in writing of the date and time of the test.

Ron Smeal mentioned that DCA needs a letter of request, stating the requested date of test.

Kelly Biddle suggested that the date of the testing would be February 26, 1994.

George Menzel questioned what kind of test would be given?

Ron Smeal mentioned the test is a general intelligence test. Which includes verbal reasoning, spelling, math, etc.

Bernard Pallo questioned if all applicants were suppose to have their Act 120?

Alfred Kerrick mentioned that it was not a requirement to apply.

Ron Smeal questioned whether or not the Commission decided on Veterans preference?

Alfred Kerrick mentioned that it was discussed by the Commission.

#### UPDATE ON LOGO

John Lamberton mentioned that the Department has decided on one logo, but still working on the color for it. The Department will submit this to the Commission at the next scheduled meeting.

#### SET DATES FOR NEXT COMMISSION MEETINGS

Alfred Kerrick set the next regular meeting for the Pocono Mountain Regional Police Commission on February 8, 1994 at 7:00 p.m.

Roy Gross suggested setting a regular time for each month, and advertise the meetings in the paper.

Kelly Biddle questioned how often the Regional Boards meet?

Ron Smeal stated they meet once a month.

Dave Moyer suggested setting the meetings for every second and fourth week of each month.

Alfred Kerrick set the next two Regional Police Commission meetings for February 8th, and the 22nd, at 7:00 p.m.

#### UPDATE ON CHIEF

Ron Smeal mentioned that there were two no show applicants for the interviews. The board will be advised of the top two applicants that were picked from the six that were interviewed.

Roy Gross suggested Ron Smeal to describe the Board who did the interviewing for Police Chief.

Ron Smeal mentioned there were two other panel members besides himself. One was a police Chief from York County, Hal Kessler, and the other was a Commander with the Frederick County Maryland Criminal Investigation Division, Alison Chapman. The panel members under went a training in assessment centers for interviewing and evaluating the candidates.

#### UPDATE ON GRANT APPLICATION /FEASIBILITY STUDY

Ron Smeal confirmed with Mr. Patten about the writing. It was satisfactory and a letter was forwarded. The Commission will receive a carbon copy of this response.

Kelly Biddle mentioned that the two applicants for Chief will be interviewed on Saturday, February 29, at 10:00 a.m. and 2:00 p.m.

#### OPEN DISCUSSION:

Roy Gross mentioned that the Pension Board needs to get together and meet. The attorney for the Pocono Mountain Regional Police Commission needs to be present to go over notes on Police Pension.

Ron Smeal mentioned that agreements need to be made by each of the two municipalities in conjunction with the Auditor General authorizing the merger of the two plans into the new one.

Bernard Pallo questioned the attorney fee instead of paying him by the hour, can he be on a retainer fee?

Alfred Kerrick mentioned that the attorney gave us a cut rate which consists of a total of \$20.00 an hour cheaper. The Township pays their solicitor by the hour and by the meeting.

Bernard Pallo mentioned that the Mt. Pocono Borough pays their solicitor by the year.

Kelly Biddle mentioned that the solicitor will be notified to attend the following Pocono Mountain Regional Police Commission meetings.

Ron Smeal mentioned that the Police officers should start looking into the ordinances that the two municipalities have.

John Lamberton questioned about the hiring of the new Chief whether he would be starting prior to the orientation of the new Regional Police Department.

Roy Gross mentioned that once the Chief is hired he would start right away in meeting everyone from both departments, etc.

Ron Smeal mentioned that he spoke with Mike Cosack who recently spoke to the commission in regards to the pension, he related that the Chief could be put under either pension plan until such time the new commission comes in. He would then get credit for his time, as it merged into the other department. You also need to decide the same for the police secretary. The police secretary is currently under the Townships pension plan. It needs to be decided whether she will continue to stay on the civilian plan with the Township or if the pension board would recommend on opening a civilian plan for her. This needs to be decided as she transfers employment. There is a certain procedure to go through that her previous holder would need to be notified.

Jeff Evans had several questions concerning the two chiefs that will be interviewed?

Alfred Kerrick mentioned that the commission will be going over the resumes of the two Chiefs after tonights meeting during the executive session.

Jeff Evans questioned whether or not the third and and fourth choice for police chief would be considered?

Alfred Kerrick mentioned that the decision to include the third and fourth choice for the the police chief interviews has not been considered as of this time.

John Lamberton questioned the starting date March first or April first when the Pocono Mountain Regional Police Department would begin?

Alfred Kerrick mentioned that April first would be more likely than March first at this point. The Pocono Mountain Regional Police Department will not be started until it is ready to be started.

John Lamberton questioned whether or not the Pocono Mountain Regional Police Department would be started prior to the new officers that will be hired?

Alfred Kerrick mentioned that the commission wants a fifteen member department before the Regional Police is underway.

John Lamberton questioned if there was another test besides the one from DCA that was given in the past?

Ron Smeal mentioned that DCA might have changed their test and are purchasing one from a company in Georgia. There are approximately three or four other tests, one is the International Managers Association, out of Maryland. The other tests that are being used are pretty compatible.

George Menzel questioned if the chief interviews were public knowledge?

#### CALL TO ORDER:

This regular meeting of the Pocono Mountain Regional Police Commission was called to order by Chairman Alfred Kerrick with the pledge of allegiance.

#### PRESENT:

Alfred A. Kerrick - Chairman Roy Gross - Vice-Chairman Kelly L. Biddle - Secretary Mario Scavello - Member Dave Moyer - Member Peter Quigley - Solicitor Ron Smeal - Consultant

Alfred Kerrick announced the following executive sessions that were held for personnel matters.

- 1. Saturday, January 29, 1994 8:00 a.m. 12:00 noon
- 2. Tuesday, February 1, 1994 6:30 p.m. 8:00 p.m.
- 3. Friday, February 18, 1994 5:00 p.m. 7:30 p.m.

Mario Scavello made a motion to consider the minutes of January 11, 1994 and January 25, 1994, seconded by Kelly Biddle. All members voted in favor.

#### BUSINESS:

#### UPDATE OF THE FOLLOWING:

#### CHIEF OF POLICE APPLICANTS

Alfred Kerrick mentioned that they are still reviewing the chief of police applicants. They are interviewing a second group of applicants which consists of six individuals on Friday, February 18, 1994.

Jeff Evans questioned what happened to the first eight applicants from the first interview?

Alfred Kerrick mentioned that two applicants out of the first group of eight were interviewed by the commission and the other applicants are being considered to interview, however the commission chose another group which consists of six more individuals from the twenty nine applicants.

Jeff Evans questioned why were the first group of individuals rejected by the commission?

Alfred Kerrick mentioned that the first group of individuals were not rejected by the commission. The top two applicants were interviewed by the commission, however the other applicants have not yet been interviewed as of this time. The commission interviewed one applicant on Friday, February 18, 1994 from the second group of individuals which consists of six applicants.

Jeff Evans questioned why the first group of applicants were not considered for an interview before the second group?

Ron Smeal mentioned that you can consider more than one group of applicants, and select some people from that group for further interviews by the commission. The commission chose fourteen people. Out of the fourteen applicants, three were referred for further interviews with the commission.

Jeff Evans questioned why the top eight candidates were not considered the best candidates for the interviews?

Ron Smeal mentioned that the top eight candidates had the best appearing resumes, but were not necessarily the best candidates. One of the applicants originally chosen for the first group, but was unable to attend the interview, was then chosen for the second group to be interviewed.

#### POLICE OFFICER APPLICANTS

Alfred Kerrick mentioned that there will be three opening slots for police officers. There are One Hundred and eighty one applicants that will be given a written exam given by the Department of Community Affairs on Saturday, February 22, 1994 at 10:00 a.m. at the Tobyhanna Elementary School in Pocono Pines, Pa.

Jeff Evans questioned when are we going to get a police chief?

Alfred Kerrick mentioned that the commission has not yet made that decision. The commission wants to make sure that the individual chosen is the right individual for the police chief position.

Jeff Evans questioned that the commission already interviewed three police chief applicants, are they going to interview more?

Roy Gross mentioned that the commission might interview more.

Jeff Evans questioned when will the Regional Police Chief be determined?

Alfred Kerrick mentioned that possibly by May 1, 1994 things will be determined, however not definitely.

Jeff Evans discussed his concerns about the time frame that it is taking to get the new police coverage.

Roy Gross mentioned that the commission was hoping to have a new chief on board in January, however it is going to take time to find the right candidate.

#### PENSION BOARD

Mario Scavello mentioned that the Pension Board had a meeting prior to the Regional Police Commission meeting with Spagnoli and Cosack a Registered Investment Advisory Firm to discuss the police pension. Board members present at the Pension Board meeting were Patrolman David Cook, Robert Hackenberg, Kelly Biddle and Mario Scavello. The Pension Board discussed with Representative Mike Cosack what his company has to offer.

The Pension Board will meet next month with PSAT, Municipal Retirement Trust Pension Representative for Mount Pocono. After we meet with the two companies the Pension Board will make a decision on which company will be handling the police pension.

#### NEW ADDRESS

Kelly Biddle mentioned the new address for the Pocono Mountain Regional Police Department is P.O. Box 2024, Pocono Pines, Pa. 18350

#### LOGO

John Lamberton showed a patch to the commission that both the Tobyhanna Twp. Police Department and the Mount Pocono Police Department agreed on, but are still working on a color for it.

Moritz can make one or two sample patches for \$150.00 which is a refundable fee if order is placed with their company.

Alfred Kerrick questioned how long it would take to order these patches?

John Lamberton mentioned when ordering the patch it would take approximately four weeks.

John Lamberton also mentioned the badges that the Department was looking into.

Mario Scavello questioned how long it would take to order the badges?

John Lamberton mentioned that before ordering the police badges you need to know what your rank structure is going to be. To order these badges it would take approx. 6 weeks.

David Moyer made a motion to have a sample patch made for the police department at the cost of \$150.00, from Mortiz Company, seconded by Mario Scavello. All members voted in favor.

#### COMPUTER SYSTEM

Henry Bockelman discussed the computer system in the Tobyhanna Twp. Police Department. The computer generates the UCR report. In speaking with Mike Spirito a sales manager for Streetguard there are a few changes that would have to be made to the computer system. The cost to upgrade the system and make the necessary changes will cost approx. \$695.00 with at least one month lead time in order for the software to be installed and up and running in time. There is a budget finance program available, that does not do payroll, or print payroll checks. It will track expenditures, and print out accounting on a day to day basis. The cost of this budget finance program is \$395.00.

Ron Smeal mentioned that there should be only one ORI number for the combined police departments.

Bernard Pallo discussed that if the computer system can not generate the payroll, and there is no software for it to do the budget, then it is not even worth considering.

Ron Smeal mentioned that the computer system should be able to keep track of your accounts receivable and payroll. There are vendors that deal with just payroll.

Kelly Biddle mentioned that Tobyhanna Twp. has all of there budgeting, accounting and payroll with Mentor SCT. SCT gave us different prices. SCT recommended the PC software, instead of a module. It is a better system and more affordable. There are a lot of different programs available to accommodate the Departments needs.

Jeff Evans suggested checking into an outside payroll service.

#### BANK ACCOUNT

Mario Scavello made a motion to open up an account for the Pocono Mountain Regional Police Department at the Mellon Bank in Blakeslee, providing that all fees are waived, seconded by Roy Gross. All members voted in favor. All signatures from the five member commission board are to be on bank cards, only two signatures are needed on payroll checks. Monies from both Tobyhanna Township and Mount Pocono are needed to open up the combined bank account for the Pocono Mountain Regional Police Department.

#### INVENTORY LIST

An inventory list is needed from both Tobyhanna Township Police and Mount Pocono Police Departments with the dollar values of inventory.

#### REGULAR MEETINGS

#### POCONO MOUNTAIN REGIONAL POLICE COMMISSION REGULAR MEETING 8 MARCH 1994

#### CALL TO ORDER:

This regular meeting of the Pocono Mountain Regional Police Commission was held at the Mt. Pocono Municipal Building in Mt. Pocono. The meeting was called to order by Chairman Alfred Kerrick with the pledge of allegiance.

#### PRESENT:

Alfred Kerrick announced the following executive sessions that were held.

- 1. February 22, 1994 8:30 p.m. 9:30 p.m.
- 2. March 5, 1994 2:00 p.m. 8:00 p.m.

Roy Gross made a motion to consider the minutes of February 22, 1994 as corrected, seconded by Kelly Biddle. All members voted in favor.

### EXECUTIVE SESSION

The Pocono Mountain Regional Police Commission were in an executive session from 7:05 p.m. to 7:30 p.m.

Alfred Kerrick read the letter dated February 24, 1994 from the Commonwealth of Pennsylvania Department of Community Affairs Acting Secretary Raymond S. Angeli. The Department of Community Affairs approved the Regional Police grant application for the Pocono Mountain Regional Police Commission project. The application was approved for the amount of \$42,400.

Kelly L. Biddle mentioned that next year the Pocono Mountain Regional Police Commission needs to reapply for the same grant. The amount of the grant would be \$33,000. The following year after that would be \$16,000.

#### UPDATE OF THE FOLLOWING:

#### CHIEF OF POLICE APPLICANTS

Alfred Kerrick mentioned that the Police Commission gave a proposal to one of the police chief applicants. This applicant was the top scorer that was interviewed by the panel. The Regional Police Commission will know his decision by Friday, March 11, 1994.

George Menzel questioned the difference in scores between the first, second, and third police chief applicants?

Ron Smeal mentioned the difference in scores from the first, second and third police chief applicants were between the high 70's to the mid 70's.

Kelly L. Biddle made a motion to have the Pocono Mountain Regional Police Consultant Ron Smeal readvertise for the position of police chief, seconded by Mario Scavello.

Mr. Rake questioned how many applicants the commission interviewed for the police chief position?

Alfred Kerrick mentioned there were twelve applicants interviewed by the panel for the police chief position.

Mr. Rake questioned if there were any other applicants other than the twelve that could have been qualified for the police chief position?

Ron Smeal mentioned that the resumes that remain do not meet the minimum requirements established by the board for the position. Mr. Rake questioned whether the twelve police chief applicants met all the requirements for the police chief position?

Ron Smeal mentioned that the twelve applicants do meet the requirements, but the Police Commission chose to interview the top three applicants.

Mr. Tighe questioned how the police commission handles the order of the motions? If they allow the public to participate?

Alfred Kerrick mentioned that the police commission does allow the public discussion on the motion before it is voted on.

Mr. Tighe questioned Ron Smeal about the scores of the top three applicants being in the low 70's to high 70's for the police chief position?

Ron Smeal mentioned that the three applicants interviewed by the panel scored in the low 70's to high 70's.

Alfred Kerrick mentioned that these scores were not based on a written test. These were scores based on oral interviews.

Mario Scavello mentioned how the interview process was handled.

Mr. Krat questioned if there was a written test for the police chief applicants?

Alfred Kerrick mentioned that the process for the police chief hiring was done by a resume.

Roy Gross discussed the oral board which consists of the Police Commission's Consultant, Ron Smeal, and his trained team and its procedures in the interview process.

Mr. Krat questioned if the resumes where checked out for verification before they were interviewed?

Ron Smeal mentioned that the resumes were checked by him and the Police Commission.

Mr. Tighe questioned if the applicants credentials were verified or not?

Ron Smeal discussed the selection procedures that were followed by the board.

Chief Henry Bockelman discussed that he was one of the applicants that were interviewed and explained that it was a very thorough and difficult process.

All members voted in favor of the motion, to readvertise for the position of police chief.

#### POLICE OFFICER APPLICANTS

Alfred Kerrick mentioned that the test was given on 26 February 1994. There were 181 police applicants, but only 105 applicants took the written test.

Kelly L. Biddle mentioned that out of the 105 applicants that took the test, the commission will conduct interviews of the top 20 of the scores of the test. The written exam will be worth 70 percent and the oral test will be worth 30 percent. The total tabulation of these will give the commission an elligible list of 5 applicants. Out of the top 5 applicants, veterans will be given preference.

Alfred Kerrick mentioned this was confirmed by DCA, Department of Community Affairs.

Mr. Krat questioned how the written exams are going to be conducted?

Alfred Kerrick mentioned that the written tests were already conducted by the Department of Community Affairs.

Kelly L. Biddle mentioned that she received the test results back, but did not inform the commission until they decided to interview the top 20 applicants, because Alfred Kerrick's son was one of applicants who took the written test. So it was not known by Alfred Kerrick where his son fell on the list. This way impropriety would not be questioned.

Mr. Krat questioned if any consideration is being given to the present police officers from both the Mt. Pocono Police Department and Tobyhanna Township Police Department?

Alfred Kerrick mentioned that the full time officers from both the Mt. Pocono Police Department and the Tobyhanna Township Police Department are automatically members of the Pocono Mountain Regional Police Department. Full time personnel not part time.

Kelly Biddle mentioned that 3 more full time police officer positions are needed.

#### PENSION BOARD

Mario Scavello mentioned that the Pension Board met prior to the Pocono Mountain Regional Police Commission meeting. The Pension Board met with Tom Klaum, a representative from the Pennsylvania State Association of Boroughs. Board members present at the Pension Board meeting were Patrolman David Cook, Robert Hackenberg, and Mario Scavello. The Pension Board discussed with Tom Klaum what his company had to offer. Tom Klaum takes care of the Mt. Pocono's pension. On February 22, 1994 the Pension Board met with Spagnoli and Cosack, a Registered Investment Advisory Firm, to discuss the police pension. Spagnoli and Cosack takes care of the Tobyhanna Township Police Department pension. At the next Pension Board meeting it will be discussed which firm the Pension Board decides to go with.

#### BANK ACCOUNT

The board had nothing to discuss at the present time.

#### COMPUTER SYSTEM/OUTSIDE PAYROLL SERVICE

Henry Bockelman discussed the computer system that is presently in the Tobyhanna Township Police Department and also the software that can be added to update the existing programs. The computer system in the department has the capability to do the budgeting, but not payroll or payroll checks.

Ron Smeal mentioned that the accounts receivable and payable can be done in the computer and the checks can be written out by hand.

Kelly Biddle questioned whether or not the Police Departments computer has the capability to track the accounts receivable?

Henry Bockelman will look into whether or not the computer can track the accounts receivable.

Ron Smeal mentioned if the computer can track the accounts receivable and payable then it would just be a matter of getting a new printer.

Kelly Biddle mentioned that she was under the impression that the Police Departments computer does not have the capability for the accounts recievable and payable. It just has the capability to record.

Henry Bockelman mentioned the computer has the capability to record the transactions and gives a balance from different accounts.

Mario Scavello mentioned to check with Mellon Bank to see if they could do payroll and how much it would cost.

Ron Smeal mentioned that because your accounts recievable and payable have to be done on a daily basis it would be difficult to run back and forth everyday.

Mr. Krat questioned whether or not the commission consulted an expert on computers with problems and needs that would have to be resolved?

Alfred Kerrick mentioned that the commission has consulted with experts on the computer system.

Jeff Evans discussed the outside payroll service that his Association is dealy with.

Jeff Evans questioned whether or not Tobyhanna Township prints there own checks for accounts payable?

Kelly Biddle mentioned that Tobyhanna Township does all of their payroll in house. The Regional will be under a different tracking system and a different name.

Jeff Evans mentioned that their particular organization can do three different Associations in the same computer system, but on different books.

Kelly Biddle mentioned that Tobyhanna Township purchased their computer software. They can sell their services but can not sell the system out to the Regional Police.

Jeff Evans questioned if Tobyhanna Township can add on a second book set for the Regional police department?

Kelly Biddle mentioned that Tobyhanna Townships computer system would have to be upgraded and to do this it would cost to much.

Ron Smeal mentioned that the Xenix System the police department currently has, does not have any software programs available to meet the departments needs.

Henry Bockelman questioned if a PC can be purchased?

Kelly Biddle mentioned already looking into prices from SCT Public Sector Inc. for PC's. The Price for two PC's would be approximately \$5,000.00.

Ron Smeal mentioned the grant budget for computer equipment. You could write this off. The inner governmental cooperation grant is coming out in June, you could receive a maximum of \$10,000.00. Check with someone from the Department of Community Affairs.

Alfred Kerrick questioned Ron Smeal regarding a computer system that his department is selling?

Ron Smeal mentioned that his department is selling their computer system, if the commission is interested in looking at it.

#### INVENTORY

Henry Bockelman is waiting on a couple of prices in order to complete his departments inventory list.

Mario Scavello mentioned that he received Mt. Poconos inventory list.

#### PATCH/BADGE

John Lamberton showed a computer sample of the regional patch.

Mr. Tighe questioned whether or not the officers wear hats?

Alfred Kerrick mentioned that the officers wear campaign hats.

Alfred Kerrick mentioned ordering the badges.

Kelly Biddle mentioned that the price for the badges were cut.

John Lamberton mentioned the price for the badges from the book were \$81.00. The price the company quoted the police department for the badges were \$51.00. A total savings of \$30.00. The cost might even be less, depending on the quantity of badges ordered.

Henry Bockelman mentioned that 2 badges per officer is needed. One for the officers shirt, and one for the officers jacket.

Mario Scavello made a motion to purchase 30 duty badges. 2-Chiefs, 2-Lieutenants, 6-Sergeants, 20-Police Officer badges. Also, 15 off duty badges, 1-Chief, 1-Lieutenant, 3-Sergeants, and 10-Police Officer, seconded by Roy Gross. All members in favor.

Mr. Menzel questioned when the officers ranks will be determined?

Alfred Kerrick mentioned that the decision has not been made to set any other positions. The commission is waiting on the police chief first before making any other announcements.

Mr. Menzel questioned if the chief will be able to make the decisions of the positions under his rank?

Alfred Kerrick mentioned that once the police chief is hired, at that time the officers rank and file will be determined. Mr. Krat questioned if the sergeants, lieutenants, and detectives are going to be given tests? Or will this be decided by the chief or the commission?

Alfred Kerrick mentioned that a written test will be given for the sergeants position.

Mr. Tighe thanked the commission for holding its regular meeting at the Mt. Pocono Municipal Building.

Mr. Rake questioned if the top scorer accepts or does not accept the police chief position, how long will it be before the Regional Police Department is on line?

Alfred Kerrick mentioned if the the top scorer accepts the police chief position, the Regional Police Department will be on line May 1, 1994. If the top scorer does not accept the position it will be longer. The commission will know by Friday, March 11, 1994 if he accepted the police chief position or not.

Mr. Krat hopes that the commission gives consideration to those who presently hold positions with the two departments.

Roy Gross mentioned that the commission will take into consideration those who presently hold positions in the two departments. No one will lose their rank other than the two chiefs.

Jeff Evans questioned if May 1, 1994 will be the first day for the police chief or the first day the Regional Police Department is started?

Alfred Kerrick mentioned that May 1, 1994 will be the first day for the chief. The Regional Police Department will start two weeks after May 1, 1994.

Jeff Evans questioned when the new police chief will be starting?

Alfred Kerrick mentioned that if the top scorer accepts the police chief position he will start 2 weeks prior. Jeff Evans questioned that if the commission has to readvertise for the police chief position, will the regional police department start without the chief? What will happen to the hiring of the new officers?

Alfred Kerrick mentioned if the top scorer does not accept the police chief position then the Regional Police Department would not start until a later date than May 1, 1994, and the new officers will then be notified.

Jeff Evans questioned about the summer police coverage?

Alfred Kerrick mentioned that Tobyhanna Township will have police coverage for the summer, but without the Regional additional coverage if the new chief is not on board.

Mr. Tighe questioned the police coverage and the officers assignments when handling Tobyhanna Township and Mt. Pocono?

Alfred Kerrick mentioned that all officers will know the locations in both Mt. Pocono and Tobyhanna Township, and it will be decided within the department the areas the officers will cover.

John Lamberton mentioned that there is a borough map of Mt. Pocono that is located on the wall in the Tobyhanna Township Police Department for the officers to study.

## REGULAR MEETINGS

Alfred Kerrick announced the next public meeting will be on Tuesday night, 5 April 1994 at 7:00 p.m. at the Tobyhanna Township Government Center Building, Pocono Pines, Pa.

## ADJOURNMENT

Mario Scavello made a motion to adjourn, seconded by David Moyer. Meeting adjourned approx. 8:35 p.m.

# POCONO MOUNTAIN REGIONAL POLICE COMMISSION REGULAR MEETING 5 APRIL 1994

#### CALL TO ORDER:

This regular meeting of the Pocono Mountain Regional Police Commission was held at the Mt. Pocono Municipal Building in Mt. Pocono. The meeting was called to order by Chairman Alfred Kerrick with the pledge of allegiance.

## PRESENT:

Alfred A. Kerrick - Chairman Roy Gross - Vice-Chairman Kelly L. Biddle - Secretary Mario Scavello - Member Dave Moyer - Member Peter Quigley - Solicitor Ron Smeal - Consultant

Mario Scavello made a motion to approve the minutes of 8 March 1994 at the next regular meeting, seconded by Dave Moyer. All members voted in favor.

Kelly Biddle made a motion to pay the bills for the Pocono Mountain Regional Police Department in the amount of \$1,952.50, seconded by Mario Scavello. All members voted in favor.

# BUSINESS:

# UPDATE OF THE FOLLOWING:

## CHIEF OF POLICE

Alfred Kerrick mentioned that the applications will be accepted for the chief of police position until April 9, 1994. The interview panel will be meeting on April 23, 1994 to interview the applicants for police chief.

Ron Smeal advised the commission to look into an Inner Governmental Cooperation Grant. The maximum amount of the grant is \$10,000.

## POLICE OFFICE APPLICANTS

Alfred Kerrick mentioned that the commission will be interviewing the top 21 police officer applicants on Saturday, April 9, 1994. The interviews will begin at 7:30 a.m. and end at 2:10 p.m. There were 21 applicants because the scores for number 20 and number 21 were tied. These interviews are for 3 full time police officer positions.

## PENSION BOARD

# EXECUTIVE SESSION

Alfred Kerrick announced there was an executive session, held on Saturday 23 April 1994 from 8:00 a.m. to 8:00 p.m. regarding personnel.

# APPROVAL MINUTES

Kelly Biddle made a motion to accept the minutes of March 8, 1994 and April 5, 1994, seconded by Roy Gross. All members voted in favor.

#### BUSINESS:

## UPDATE OF THE FOLLOWING:

# CHIEF OF POLICE INTERVIEWS

Alfred Kerrick mentioned that the executive session held on April 23, 1994 was for the interviews with the additional police chief applicants. A conditional offer might be offered at tonights executive session after the regular meeting to one of two final top candidates that were interviewed.

## POLICE OFFICER INTERVIEWS

Alfred Kerrick mentioned that the interviews were held on April 9, 1994. Three conditional offers were given.

Kelly Biddle mentioned that all three applicants for the police officer position have accepted their conditional offers.

Alfred Kerrick mentioned that out of the three individuals chosen for the police officers position, only one of them needs the Act 120 training. The other two individuals are trained to go out on the road.

Alfred Kerrick mentioned that there is a school available in May and also in July that offers the Act 120 training.

#### PENSION BOARD

Mario Scavello mentioned that the pension. board had a meeting today April 26, 1994 at 3:00 p.m. at the Mt Pocono Municipal Building. The pension board met with Spagnola and Cosack. The pension board decided on how the portfollio would be diversified. There are 11 officers in the 12 1/2 years of service. The average age is 38 years old. There will not be for at least 3-4 years, anyone drawing from this plan. The total between Mount Pocono Borough, and Tobyhanna Township dollars, is approximately \$760,000.00 that will be going into this plan. The monies that are going into this plan will be invested into equities and fixed incomes. The break down for this will be a 10% annual return income. The money managers will be discussed and decided at the next pension board meeting. It has been agreed that for the next 3-4 years no monies will be distributed, only 6% of cash will be held.

Alfred Kerrick suggested that a resolution be made to appoint Spagnola and Cosack to be the pension board managers.

Mario Scavello made a motion to appoint Spagnoli and Kosack to be the pension board managers for the Pocono Mountain Regional Police, seconded by Kelly Biddle. Mario Scavello mentioned reviewing the pension plan before making a motion.

Kelly Biddle questioned if a resolution is needed for each plan or just for the company?

Mario Scavello mentioned that the portfollio contains information of how the monies will be distributed and invested.

Kelly Biddle suggested that if any modifications to this plan in the future need to be made, then there is no need for this resolution.

Mario Scavello mentioned that there are other alternative plans.

Kelly Biddle mentioned the Resolution number would be 94-01.

All members voted in favor of the Pension Plan Resolution #94-01.

# PROPOSALS FROM SERVICE STATIONS FOR MAINTENANCE/GASOLINE

Alfred Kerrick mentioned that 11 letters for proposals for maintenance/gasoline were sent out to all the garage owners in both Tobyhanna Township and Mount Pocono. The commission only received one proposal back as of 26 April 1994. All proposals must be sent into the commission by May 10, 1994.

David Moyer suggested having a second service station to maintenance the vehicles, just in case the other station can not maintenance the vehicle right away.

Roy Gross suggested having two service stations one for maintenance, and one for gasoline.

Alfred Kerrick mentioned that once all the proposals are submitted into the commission then a service station will be determined for maintenance/gasoline.

## PATCHES/BADGES

John Lamberton mentioned that the patches and the badges for the Pocono Mountain Regional Police Department have been ordered.

Joann Yakscoe mentioned that there were 400 patches ordered, not 600 as quoted at the last regional meeting. A thank you letter will be sent to Moritz Embrodiery Company after the patches have been received by the police department.

#### BILLS TO BE PAID FOR REGIONAL POLICE

Kelly Biddle mentioned that there were two bills that needed to be paid in the amount of \$2,935.50.

Kelly Biddle made a motion to pay two bills in the amount of \$2,935.50, seconded by Roy Gross.

Alfred Kerrick mentioned that the two bills were for badges and legal services.

All members voted in favor to pay the two bills for the regional police.

Kelly Biddle mentioned that more money is needed for the regional bank account. After the two bills are paid in the amount of \$2,935.50 there is only a minimal amount left in the regional bank account.

Kelly Biddle mentioned a total of \$5,000.00 is needed from both Tobyhanna Township and Mount Pocono for the regional bank account.

Kelly Biddle suggested applying for a tax-exemption status since the regional police qualifies for it.

#### OPEN DISCUSSION

Jeff Evans questioned about the chief of police and the three new police officers for the regional police department?

Alfred Kerrick mentioned that the regional police will be holding an executive session after the regular meeting and a conditional offer might be given at that time to one of the top two candidates for the police chief position. The three police officer candidates have accepted a written conditional offer and are presently working other jobs. The three police officer candidates were given a time frame which they agreed upon, and also were told about the regional police departments process by the regional police commission.

Jeff Evans questioned if June 1, 1994 is the starting date for the regional police department?

Alfred Kerrick mentioned that the month of June is a probable date for starting the regional police department.

John Lamberton suggested having the regional police department get their gas at the Tobyhanna Township Municipal Building. This is where the police presently get there gas. It makes it more convenient especially late at night when there are no other stations open.

Alfred Kerrick suggested waiting until all proposals are sent into the commission by May 10, 1994 before a decision about gasoline/maintenance can be made. Then the proposals will be looked over and discussed. If comparable in price there is a possibility that the police can purchase their gas during the day and be able to get gas at night at the Tobyhanna Township Municipal Building.

Mr. George Menzel mentioned that it would be cheaper in price to have the gas at the Tobyhanna Township Municipal Building.

Jeff Evans mentioned that having the gasoline available to the officers is extremely important.

#### NEXT REGULAR MEETING

Alfred Kerrick mentioned that the next regular meeting for the regional police commission will be held on May 10, 1994 at 7:00 p.m. at the Tobyhanna Township Municipal Building.

Mario Scavello mentioned that there will no longer be regular meetings held at the Mount Pocono Municipal Building.

Mario Scavello made a motion to accept the minutes of April 26, 1994, seconded by Kelly Biddle. All members voted in favor.

# BILLS TO BE PAID

Roy Gross made a motion to pay two bills in the amount of \$163.85, seconded by Mario Scavello. All members voted in favor.

Peter Quigley mentioned the conditional offer states the starting date, with the exception of William Laverty, will be the start of the police force date.

All members voted in favor of the three new police officers.

# CONSIDER EXPENDITURE OF FUNDS FOR POLICE OFFICER ACT 120 TRAINING

Alfred Kerrick mentioned that William Laverty, one of the new police officers hired for the Pocono Mountain Regional Police Department needs to obtain his Act 120 training.

Mario Scavello made a motion to spend the funds to send Officer William Laverty to the Act 120 training on May 23, 1994, seconded by Kelly Biddle. All members voted in favor.

# CONSIDER RESOLUTION 94-002 POLICE PENSION PLAN

Peter Quigley mentioned that resolution 94-002 has to deal with the existing pension funds for the Tobyhanna Township Police Force and the Mount Pocono Police Force. At the last regular meeting for the Pocono Mountain Regional Police this proposed unified plan was discussed by the board. The proposed unified plan consists of the two pension funds that are merged into one pension plan to accommodate the police officers of the new Pocono Mountain Regional Police Force. Resolution 94-002 details some of the history of how this force is about to come into creation.

Alfred Kerrick introduced Chief Robert Martz. He has a bachelors of science degree in business education from Shippensberg University in 1969. He received his diploma from the Pennsylvania State Police Academy in Hershey Pennsylvania in 1972. He attended Luzerne County Community College and the Pennsylvania State University. He also received additional courses and instructions from the Federal Bureau of Investigations, the United States Attorneys Office and the Internal Revenue Services. He joined the Pennsylvania State Police in 1972. He is presently Captain in the Pennsylvania State Police with the Bureau of Liquor Control Enforcement.

Chief Martz introduced himself. For the past year 1/2 he worked as Director of Operations for Liquor Control Enforcement, commanding 158 enforcement officers, at nine district offices from Erie to Philadelphia. He has been with the State Police for 22 1/2 years, and retiring as Captain on Friday, May 20, 1994.

Alfred Kerrick thanked Ron Smeal the Consultant for the Pocono Mountain Regional Police Commission and his staff for all their hard work in the hiring process for the police chief position.

# PENSION BOARD

# POCONO MOUNTAIN REGIONAL POLICE COMMISSION REGULAR MEETING 24 MAY 1994

## CALL TO ORDER:

This regular meeting of the Pocono Mountain Regional Police Commission was called to order by Chairman Alfred Kerrick with the Pledge of Allegiance.

#### PRESENT:

Alfred A. Kerrick - Chairman Tom Reed - Alternate Member Kelly L. Biddle - Secretary Mario Scavello - Member Dave Moyer - Member Peter Quigley - Solicitor Ron Smeal - Consultant

# EXECUTIVE SESSION

The Pocono Mountain Regional Police Commission were in an executive session from 7:05~p.m. to 7:10~p.m. to discuss a personnel matter with Alternate Tom Reed.

Alfred Kerrick mentioned that Tom Reed from the Mount Pocono Counsel will be the alternate to fill in for Roy Gross who just recently suffered from a heart attack. Tom Reed was nominated by the Borough Counsel to be an alternate for Roy Gross.

Alfred Kerrick also mentioned there was an executive session held on May 10, 1994 from 8:00 p.m. to approximately 10:00 p.m. for a personnel matter, interviewing employees for the position of Lieutenant.

# APPROVAL MINUTES

Mario Scavello made a motion to accept the minutes of May 10, 1994, seconded by Dave Moyer. All members voted in favor.

# BILLS TO BE PAID

Kelly Biddle made a motion to pay the bills in the amount of \$6011.21, seconded by Mario Scavello. All members voted in favor.

Dave Moyer questioned the \$50.00 per day for meal expense?

Kelly Biddle stated that the Township Policy has always been \$50.00 per day for meal expense. If the employee attends school or goes away on a business trip they are given \$50.00 per day for three meals and must return all receipts and money that was not used.

Chief Robert Martz questioned whether this meal expense qualifies for reimbursement from the Municipal Police Training?

Kelly Biddle stated that the meal expense does qualify for reimbursement from the Municipal Police Training.

Chief Robert Martz stated that some of the monies will be coming back in a form of a reimbursement from the Municipal Police Training Commission. They reimburse us for a certain amount the training expenditures.

Kelly Biddle stated the reimbursement from the new officers training is approximately 75%.

Alfred Kerrick stated 50% of the officers salary is also reimbursed.

Tom Reed stated that the commission should set up some new rules instead of going by what one municipality goes by.

Kelly Biddle stated that the \$50.00 per day meal expense was decided because the officers are following the Township contract.

Alfred Kerrick wants to check the Township contract to see if there is any dollar amount for the meal expense. If there is not a dollar amount for meal expense, then the commission can discuss this with Chief Martz and come up with a dollar amount.

All members voted in favor.

## DECALS FOR POLICE CARS

Alfred Kerrick mentioned that the commission has a small version of the decals for the police cars but it will not be presented until the next meeting.

## PENSION BOARD

Mario Scavello mentioned that the pension board had a meeting today, May 24, 1994, at 5:00 p.m. at the Tobyhanna Township Government Center Building. The pension board met with representative Cosack from Spagnola and Cosack. Present at the meeting were Bob Hackenberg Dave Cook from Tobyhanna Township Police Department and Mario Scavello. The Pension Board will meet on June 7, 1994 to discuss if there will be any further changes that need to be made to the pension plan. Tobyhanna Townships dollars have been released and the check was given to Mr. Cosack to be put into an account right now. When the funds from Mount Pocono are put in, it will be distributed accordingly according to the way it was agreed, the dollars will be separated.

Alfred Kerrick mentioned that by purchasing the gasoline from Tobyhanna Township it would be available 24 hrs. a day.

Chief Robert Martz mentioned that there are considerable amounts of record keeping, and book keeping involved in order to submit to the state and the Federal Government for tax refunds.

Henry Bockelman mentioned that it is definitely a savings to buy gasoline in bulk.

Tom Reed made a motion to use Tobyhanna Township as the gas supplier for the Pocono Mountain Regional Police Department, seconded by Kelly Biddle.

Tom Reed questioned if there is a time period? How long will 62 cents a gallon be good for?

Ron Smeal questioned Kelly Biddle regarding rebidding the gasoline? January?

Kelly Biddle mentioned that the .62 cents is not a yearly price. It changes according to the contract as do all of these. It changes according to that week or month.

Alfred Kerrick questioned about the state piggy back that the Township is guaranteed one set price?

Kelly Biddle mentioned that the price can not go above a certain percent. The .62 cents is not guaranteed. It can fluctuate. The \$687.50 per year for insurance was just paid for by Tobyhanna Township.

Mr. Menzel questioned the capacity of the Tobyhanna Township gasoline tanks?

Kelly Biddle mentioned the capacity for the Tobyhanna Township gasoline tank is 8,000 gallons. The tank is checked every week. When more gasoline is needed it takes approximately 2 days to receive.

Alfred Kerrick mentioned that there are different size tanks in the ground. The tank the Regional Police will be using is a 8,000 gallon tank.

All members voted in favor.

REPRESENTATIVE - PAUL PUGIELLI BOWERS, SCHUMANN & WELCH INSURANCE

Mr. Paul Pugielli, Representative from Bowers, Schumann & Welch Insurance, presented his proposal of insurance to the Pocono Mountain Regional Police Commission. This insurance is for the new Pocono Mountain Regional Police Department. It is a combination of coverages for the police employees that were covered under the Tobyhanna Township insurance policy. Bowers, Schumann & Welch Agency located in Bethlehem handles insurance for over fifty municipalities.

Alfred Kerrick mentioned that Chief Robert Martz will be working as of June 1, 1994 and will be insured as of June 1, 1994. Mount Pocono Police Departments insurance will be picked up by Tobyhanna Township as of June 1, 1994, because their old policy will no longer be in effect. When Tobyhanna Township and Mount Pocono join forces on June 13, 1994 as the new Pocono Mountain Regional Police Department they will all be combined as one policy.

Representative Pugielli will bind the policy without a deposit.

Mario Scavello made a motion that the commission agreed to purchase insurance from the Genstar Group through Bower, Schumann & Welch as Agents for the Public Official Liability Policy and the Law Enforcement Liability Policy, with a \$250,000.00 coverage, seconded by Dave Moyer. All members voted in favor.

Peter Quigley recommended the motion for the insurance coverage, and strongly suggests that the commission goes with at least \$100,000.00 to \$250,000.00 for the uninsured/insured motorist coverage. This is an extremely important coverage.

# UPDATE OF HEALTH INSURANCE

Kelly Biddle mentioned that the Health Insurance through Blue Cross/Blue Shield will be effective, but the Pocono Mountain Regional Police Department has to go on the Tobyhanna Township Policy for the first two weeks, then they start their own policy.

# NEXT REGULAR MEETING

Alfred Kerrick mentioned that the next regular meeting for the Regional Police Commission will be held on June 7, 1994 at 7:00 p.m. at the Tobyhanna Township Municipal Building.

The Commission took a recess at 8:30 p.m. to 8:42 p.m.

Mario Scavello made a request to hold an executive session on a personnel matter after the regular meeting and also wanted the Mount Pocono Council to be moved down on the Agenda.

#### OTHER BUSINESS:

#### RECOMMENDATION FOR LIEUTENANT

Chief Robert Martz and Chief Ron Smeal conducted oral board examinations with the potential candidates on Tuesday, May 10, 1994. The oral boards were scored independently by Chief Robert Martz and Chief Ron Smeal. The scores were then combined with earlier oral board scores from other interviews that were given previously. When the scores were tabulated the highest score was the present Chief of the Tobyhanna Township Police Department, Henry Bockelman.

Chief Robert Martz recommended that Henry Bockelman be named for the Lieutenant position to the Pocono Mountain Regional Police Department.

David Moyer made a motion to appoint Henry Bockelman as Lieutenant for the Pocono Mountain Regional Police Department, seconded by Mario Scavello. All members voted in favor, with the exception of Alternate Tom Reed, he abstained because he was not involved with any of the prior interviewing.

## OPEN DISCUSSION

Tom Reed questioned who would be servicing the police vehicles?

David Moyer stated to readvertise for proposals for the maintenance of the police vehicles.

Chief Martz stated that when any maintenance is required the commission could seek out bids.

Alfred Kerrick stated that seeking out bids for the maintenance of the police vehicles would be the best way to go. In the mean time, he suggested the Tobyhanna Township Maintenance Department could do the repair work.

Kelly Biddle was against the Tobyhanna Township Maintenance Department fixing any of the police vehicles, because of the road repair work they are currently doing. They would not have the time.

Alfred Kerrick stated that Tobyhanna Township has their own Inspection Mechanic.

Alfred Kerrick stated that the Chief of Police could notify the different garages for quotes at the time the service is needed.

Jeff Evans stated that since all the police vehicles are Chevrolets, depending on the warrantee of the vehicles have Ray Price Chevrolet service them.

Alfred Kerrick stated that the police vehicles are serviced by Ray Price Chevrolet if they are under warrantee. The Fern Ridge State Police Barracks uses Blakeslee Garage for the servicing of their police vehicles.

Chief Martz mentioned that the State Police are not bound by any bidding procedures. Each State Police Barracks has their own maintenance garage.

The commission suggested that the Chief of Police will decide where the police vehicles are serviced.

Peter Quigley mentioned that it is not necessary for a motion unless the commission requests a motion on the maintenance of the police vehicles.

The Mount Pocono Counsel wished to be withdrawn from the Agenda.

Alfred Kerrick stated that all Mount Pocono Citizens are welcomed to address any questions that they might have at the Pocono Mountain Regional Police Commission meetings and the questions will be answered by the Commission.

Kelly Biddle stated that the Mount Pocono Counsel requested to know where the \$10,000.00 for the Pocono Mountain Regional Police Department was spent. Kelly Biddle drew up a list to show the Mount Pocono Counsel where all the expenditures went, and mentioned that the Mount Pocono Borough only gave a total of \$7,500.00 not \$10,000.00. A check for \$2,500.00 in March, and a check for \$5,000.00 two weeks ago. Every bill pack is approved at every Pocono Mountain Regional Police Commission meeting.

Mount Pocono Counsel mentioned that Lori Yocum came up with a \$10,000.00 figure because she added in the salaries.

Kelly Biddle stated that the expense for salaries that were added into the Mount Pocono figure was paid through Mount Pocono only, Tobyhanna Township has no record of what Mount Pocono paid, only a record of what Tobyhanna Township or the commission paid. Tobyhanna Township also put out approximately \$1,000.00 for advertisements, and postage, etc. which have not been reimbursed for and should be presented at the next meeting.

Chief Martz stated about the letters of notification he needs to send to the Municipal Police Training, ORI numbers, U.C.R reports in Harrisburg etc. require a notification of the police department and providing the enabling ordinances from each Municipality indicating the effect date of the new department and the ordinance abolishing the existence of the local Municipality department on the new department starting up. The letters of notification are all done, however these copies are needed of the ordinances to send along with the letters.

Alfred Kerrick stated that Tobyhanna Township will be enacting the ordinance of the new Pocono Mountain Regional Police Department on June 6, 1994 at their special meeting. Mario Scavello stated that Mount Pocono Borough will be enacting their ordinance around the same time frame.

Peter Quigley has a copy of ordinance creating the Pocono Mountain Regional Police Commission.

Chief Martz stated that both Municipalities are scheduled to have the new ordinances enacted before June 13, 1994.

Alfred Kerrick stated that there will be two executive sessions held prior to the next regular meeting. One executive session called by Mario Scavello and the other executive session held for the interviews of Sergeants.

#### OTHER BUSINESS:

Chief Robert Martz stated that Tobyhanna Township Police Department and Mount Pocono Police Department both have a cooperative agreement with all the Municipalities in the area. They are now a separate police entity, Pocono Mountain Regional Police Department. Chief Martz will be approaching other police departments and initiate similar agreements.

Alfred Kerrick gave Chief Martz permission to go ahead with contacting other police departments to initiate similar agreements.

Chief Martz mentioned that a stamp machine is needed for the police department. The cost will be \$160.00 for rental of the machine. The department will be billed quarterly. The cost for postage is separate.

Alfred Kerrick mentioned that with the police assistance grant from Department of Community Affairs, they will be getting the interest.

Mario Scavello stated that the pension board met at 5:30 p.m., June 7, 1994 at the Government Center Building. Present at the meeting were Bob Hackenberg, David Cook and Mario Scavello. At the meeting the pension board reviewed and discussed the police pension plan. The pension board will meet again in September when they receive their quarterly report. The pension board also mentioned that they are looking into a pension plan for a non-uniformed employee, Joann Yakscoe.

Kelly Biddle stated that Michael Cosack is working on a pension plan at this time for non-uniformed employee, Joann Yakscoe.

# CHIEF UPDATE

Chief Robert Martz gave an update to the police commission starting from June 13, to June 26, 1994 for the first two weeks of service. Hours of service for Tobyhanna Township provided was 811 3/4 hrs of coverage, and Mount Pocono received 300 hrs of coverage, 73% of coverage to Tobyhanna Township, 27% of coverage to Mount Pocono. The purchase allotted time for Tobyhanna Township was 77.5% which is 4 1/2% under on their service, Mount Pocono was 4 1/2% above their service.

This will be adjusted during the next two week period to bring it back in line. The number of complaints from Mount Pocono were high as expected it would be with the new police department. 4 1/2% is well within line and easily adjusted so the department is on line as far as purchased service. During the two week period the Regional Police Department responded to 254 complaints in both Municipalities. For the entire month of May was just over 320. The demand for service with the creation of the new police department has picked up. In the two week period there were 63 criminal arrests made in Tobyhanna Township, and 17 made in Mount Pocono. There were 7 traffic arrests in Tobyhanna Township and 21 traffic arrests in Mount Pocono. The Chief of Police will have a full report at the next regular meeting for the entire month of June and monthly there after.

Alfred Kerrick mentioned that the police department at the present time is operating one man short.

Chief Robert Martz stated that one man is presently in school which is administrative time, and one man in training, his time counts but it only puts one patrol vehicle on the road. Its a two man patrol because he is in training. The amount of coverage will increase when the two men go on the road by themselves with the addition of the new patrolman that will joining the force in August.

Chief Robert Martz mentioned that the police department is on line with all required insurance's. Contracts were signed for the Disability and Life Insurance's.

Solicitor Peter Quigley mentioned that he would like to review the coverage again from Bowers, Schumann, & Welch Insurance.

# NEXT SCHEDULED MEETING

The next scheduled meeting for the Regional Police Commission will be held on July 19, 1994 at 7:00 p.m.. After the month of August the commission will hold its regular meetings every third Tuesday of every month thereafter at 7:00 p.m.
