LSA GRANT

Chief Wagner reported PMRPD received \$50,000 of the original request of \$100,000 Grant for the in-car cameras. The \$50,000 will be used to upfit existing vehicles. 2019 vehicles will have the camera costs built in to the upfit. There is \$25,000 forfeiture from the Monroe County District Attorney's office that will be used for servers for the data storage. Chief stated we will be working on a policy and procedure for the camera program. It was stated the cameras run about \$5,000 per vehicle.

25th Year Anniversary

June marks the 25th Anniversary of PMRPD. Chief stated we will set the date after the school district sets the date for graduation. Once the date is confirmed the Chief will reach out to commission and the committee that volunteered.
